

## START candidate's declaration

I hereby declare as follows:

1. I declare that I have reviewed the *Rules for stipends for young researchers in the START programme of the Foundation for Polish Science* and undertake to comply with the rules.
2. I consent to processing of my personal data by the Foundation for Polish Science for the purpose of organization and realization of FNP programmes, and in particular in the process of selection of laureates in this programme.
3. I also acknowledge that:
  - a) Submission of data is voluntary, but refusal to provide it will make it impossible to participate in the recruitment process for this programme.

  - d) With respect to the data provided to FNP, I have the rights indicated in the Personal Data Protection Act of 10 May 2018 and the General Data Protection Regulation, specifically: the right to access and rectify the data, the right to removal or restriction of processing of the data, the right to object to processing of the data, the right to withdraw consent at any time, the right to transfer the data, and the right to file a complaint with the supervisory authority, i.e. the president of the Personal Data Protection Office.
4. I consent to providing this application to experts conducting evaluation and assessment, and consent to providing information for the purpose of evaluations conducted by the Foundation for Polish Science or other authorized entities, regardless of the result of the competition procedure.
5. I declare that in the event that I receive a stipend, I consent to placement on the Foundation's website of information about the results of the competition, including information about the candidate and his or her accomplishments, as well as the amount of the stipend.
6. I declare that in the event that I receive a stipend, I consent to processing of my personal data to the extent necessary for organization of the START stipend award ceremony, during the ceremony, and also in related promotional materials.
